- ✓ District Membership Must be 100% +3 by April 30, 2026
- ✓ Within thirty (30) days after assuming the duties of District President, submit to the District Commander of the corresponding District of the VFW, the last quarterly audit, membership status report and such additional records as may be required by the Liaison Committee. (See Article VIII, Section 810)
- ✓ Provide a School of Instruction at each District meeting highlighting at least 4 programs Per meeting by the District Chairmen
- ✓ District Auxiliary President and Treasurer <u>must</u> be bonded by August 31, 2025. (VFW Aux. By-Laws; Sec.814-Auxiliary Treasurer, page 90)
- ✓ All District Officers <u>must</u> have dues paid and received at National by <u>December 1, 2025.</u> (VFW Aux. By-Laws; Sec. 104, Page 15)
- ✓ All District Audits <u>must</u> be received by the Department Treasurer within 15 days following the District Meeting.
- ✓ All VFW Auxiliaries within your District <u>must pay</u> Health & Happiness of \$.25 per member based on <u>June 30, 2025</u>, membership to National Headquarters by April 15, 2026.
- ✓ The District President <u>shall</u> attend all Department Meetings including School of Instruction. If you, as District President, are unable to attend, then an excused absence must be sent to the Department President & Department Secretary along with the name of representative (District Sr. Vice or Jr. Vice President) who will be attending in your absence along with their District Officer title.
- ✓ District President <u>must</u> conduct an Official Visit (VFW Auxiliary By-Laws; Sec. 810C; page 75) to each VFW Auxiliary in their District & forward the Official Report Form of said visit to the Department President no later than January 31, 2026.
- ✓ All Auxiliaries within the District <u>should</u> have reported in **Americanism**, **Veterans and Family Support**, **Legislation and Hospital** by **April 15**, 2026.
- ✓ Each Auxiliary <u>must</u> pay a minimum of **\$25.00** donation to National President Lois Callahan's Special Project "VFW National Auxiliary Continuing Education Scholarships" by April 15, 2026. (This <u>must</u> be sent to VFW National VFW Auxiliary National Headquarters, 406 W. 34th Street, 9th Floor, Kansas City, MO 64111.

The donation may be paid through MALTA under "Gifts".
