
### Department President Special Project

- Q. Do we have to pay District dues?
- A. According to Article V, Sec 506–District Dues the delegates ... may access annual dues not to exceed fifty cents per member per

- Auxiliary. Dues are based on June 30 membership. Dues should be remitted by September 30.
- Q. Does an applicant always Q. need to provide proof of eligibility? A.
  - . According to Article 1, Sec 109 third bullet, "Applicants whose eligibility is already a member of that Post need not show proof of eligibility." And Article 1, Sec. 106 "Applicants who wish to transfer between Auxiliaries
- need not show proof of eligibility but must instead provide their current membership card...."
- How many trustees sign the audit?
- A. According to Article VIII, Sec 814 "All audits are to be completed by the elected Trustees with a minimum of two (2) in attendance. At least one (1) must be an elected Trustee.
